1. Call to Order

The June 15, 2026 meeting of the Accomack-Northampton Planning District Commission (A-NPDC) was called to order by Chairman Mapp at 7:00 p.m.

2. Invocation

Commissioner Major offered the Invocation.

3. Minutes of the May 18, 2026 Meeting

The minutes of the May 18, 2026 Meeting were presented. Commissioner Hart moved to approve the minutes as presented. It was seconded by Commissioner Turner, the motion was carried by unanimous vote.

4. Financial Status Report

The report indicated 87.59 percent of the proposed FY 2026 Budget had been expended while 92 percent of the fiscal year had passed.

Commissioner Crockett moved to approve the Financial Status Report as presented. It was seconded by Commissioner Hart, the motion was carried by unanimous vote.

5. Financial Statement / Bills Payable

The Financial Statement, including the current Bills Payable, were presented. Commission approval of the Financial Statement and current Bills Payable were requested.

Commissioner Crockett moved to approve the Financial Statement and Bills Payable. It was seconded by Commissioner Hart, the motion was carried by unanimous vote.

6. FY 2027 Draft Budget

The Budget Committee met prior to the June Commission meeting to review the proposed FY 2027 Budget /Annual Work Program.

Projected Revenues included the following:

- Level State and level funding from the localities are included.
- The following grants have been submitted:
 - EDA \$210T - 3 years
 - Build Working Waterfront Maritime \$1.7M

The grant listed below will be submitted in the future:

- CDBG - Horntown Project Grant \$1.25M

Projected Expenditures included the following:

- As directed by the A-NPDC Commissioners to follow the Accomack County guidelines established in their budget and Personnel Policies, a 2% salary increase for all employees and the Executive Director effective 7/1/2026 is projected in the current year budget.
- The VRS benefit of Health Insurance Credit remains the same at 1.01%.
- Health Insurance Premium rates increased by 20% and dental rates increased by 10%. The FY2027 budget reflects the amount paid on behalf of the family health insurance plans. The amount paid for any family insurance plan is \$150 per month or at least 41% of the total health insurance premium.
- Fringe Rate increased for full-time staff from 28.82% to 28.91%. The fringe rate increased primarily due to changes in employee coverage.
- Operating expenses had been reviewed and adjusted accordingly as compared to current estimates and year-to-date expenses for April 2026.

Other notes included the following:

- Excess revenues over expenditures are projected to be \$20,200.

- The FY2027 projected indirect cost rate is projected at 33.33%. The Indirect Cost Rate Agreement was submitted to the U.S. Department of the Interior on 12/22/2025. An Indirect Cost Rate Agreement is expected by the end of June.
- Updated FY2027 pay range schedule to align with inflation.

Commissioner Crockett moved to adopt the FY 2027 Budget / Annual Work Program. It was seconded by Commissioner Turner, the motion was carried by unanimous vote.

FAA Uncrewed Aerial Systems College Initiative & Talent Pipeline Program

The Eastern Shore Community College, in partnership with the Aerospace Academy of the Eastern Shore received Virginia Growth and Opportunity Act (GO Virginia) funding of \$788,700 to establish an Uncrewed Aerial Systems (UAS) workforce program. Effective May 1, 2026, A-NPDC is administering the two-year grant. ESCC has launched a new unmanned systems curriculum, including FAA Part 107 Licensing, Information Systems, GIS and Cybersecurity certifications, UAS Flight Operator and UAS Maintenance and Operations certificates, Aviation Mechanic Certificates, and PMP, CNC Programming, and Additive

Manufacturing credentials. Associate in Applied Sciences Degrees will be offered in Electronics Technology, Technical Studies, and Engineering.

3640

VDOF Urban & Community Forestry

This \$90,000 grant will be used to install native plants along the Treherneville/Birdsnest sections of the Eastern Shore Rail Trail, by a qualified landscape contractor using biochar as a soil amendment. A-NPDC staff is providing educational outreach to the community by having a dedicated page on its website devoted to the project for education of the public regarding the benefits of planting native species, providing a species list & their history on the Eastern Shore of Virginia, and the benefits of using biochar in tree plantings.

DEQ Regional Water Supply Plan

For the second year of the performance period, through June 30, 2026, A-NPDC will receive \$9,240 reimbursement from the Virginia Department of Environmental Quality (DEQ) to offset the cost to prepare the region's water supply plan. DEQ has designated A-NPDC as the regional planning unit (RPU) to represent the Eastern Shore's counties and incorporated towns.

DEQ/CZM Technical Assistance & Resiliency Planning

Work is nearing completion for the FY26 period: 10/01/2025 - 9/30/2026, amounting to \$64,500 federal funding and \$64,500 match. Projects for FY26 include Technical Assistance, Engagement, Coordination, and Trainings; Navigable Waterways, Wetlands & Groundwater Preservation and Protection; Updating the A-NPDC website; completing the Hazard Mitigation Plan Update; facilitation and support of state agencies in resilience planning efforts. Work has begun to update the A-NPDC website. Shore Strong sessions have been scheduled, and leadership training for localities continues.

BUILD Eastern Shore Rail Trail Project

Environmental reporting work required by NEPA is well underway and will be completed in August. Project trailheads that will include bus stops are also under conceptual design beginning with Birdsnest. The Engineer of Record contract continues to be negotiated. The VDOT survey of the entire 49.1 miles, using the General Assembly's allocation of funds to the Eastern Shore Rail Trail, as one of five priority trails in Virginia, will be submitted to A-NPDC by July 31, 2026.

VDEM Hazard Mitigation Plan 2026

All comments and revisions to the draft update of the Hazard Mitigation Plan have been addressed and submitted to FEMA. FEMA will provide final review and comments before the end of the federal fiscal year. The project is on track for an on-time, on-budget completion.

The Eastern Shore Regional Navigable Waterways Committee held its second quarterly meeting of CY2026 on April 30, 2026. Since the Committee's January meeting, staff efforts have remained focused on project readiness, near-term funding, and regional dredging coordination. A-NPDC advanced its FY27 Virginia Marine Resources Commission Waterway Maintenance Fund request for Folly Creek as a mechanical dredging effort with contractor-sourced upland placement as the baseline disposal pathway. On April 21, 2026, the VMRC Board approved \$1,000,000 in funding for Eastern Shore work. On May 14, a Memorandum of Understanding was entered into by the VMRC and A-NPDC. While this award represents partial funding against Folly Creek's current estimated cost of approximately \$2.744 million, it allows the project to move forward on a staged path toward procurement and construction while reducing disposal, siting, and permitting risk. At its April 30 meeting, the ESRNWC also supported continued development of the beneficial use pathway as a parallel track to the core Folly Creek navigation project, including partner outreach and site-control discussions for screened marsh candidates, identification of feasible monitoring partners and realistic monitoring scopes, and prioritization of near-term feasibility work so that a beneficial use add-alternate can be advanced credibly when funding and permissions align. In parallel, work continues on Nassawadox Creek material management planning, broader regional dredging coordination, and implementation of the Dredge Material Management Initiative. The next ESRNWC meeting is scheduled for August 20, 2026.

Coordination with the Town of Tangier and state and federal partners continues to advance the Tangier Island beneficial use pathway as the primary material management approach for Nassawadox Creek following VMRC's denial of the prior nearshore berm proposal. Current review remains focused on the East of Runway site, Beach Area uplands, Beach Fill and berm area, and the North Port transfer and offload location, pending confirmation of physical constraints. The NV5 survey work is now complete, and the Terracon field investigation has also been completed, providing additional information needed to support the revised placement and permitting package. U.S. Fish and Wildlife Service also indicated that the proposed Tangier locations are unlikely to be suitable Northeastern beach tiger beetle habitat and did not recommend a time-of-year restriction for the proposed beach beneficial use locations. Permit submission is now targeted for late June 2026 to allow incorporation of the completed survey and field data, follow-up coordination with regulators, and continued coordination with the Town of Tangier on site logistics and implementation considerations. Pending regulatory review and further Town coordination, the current implementation goal is Fall 2026.

The Folly Creek Phase 1B package remains well positioned for implementation, with the draft Joint Permit Application package, Folly Creek-specific Dredged Material Management Plan, sediment and vibrocore data, and permit figures substantially advanced and in hand. The FY27 Waterway Maintenance Fund request was advanced as a mechanical dredging approach using barge or scow movement and transfer and offload at the Folly Creek Landing and boat ramp area, with contractor-sourced upland placement serving as the baseline disposal pathway. On April 21, 2026, the Virginia Marine Resources Commission Board approved \$1,000,000 in funding for Eastern Shore work. Although this award represents partial funding against the project's current estimated total cost of approximately \$2.744 million, it supports a staged path toward procurement and construction while additional coordination and disposal readiness work continues. In parallel, the ESRNWC has supported continued development of a beneficial use add-alternate as a parallel track to the core navigation project, including continued outreach and site-control discussions for screened marsh candidates, identification of feasible monitoring partners and realistic monitoring scopes, and targeted near-term feasibility work so that a beneficial use option can be advanced credibly if funding and permissions align. Staff will also continue agency coordination, finalize procurement strategy, and complete remaining readiness items, including the table of adjacent property owners.

The project was reactivated once VRA agreed to reimburse the A-NPDC for funds expended. A consulting firm has been hired to prepare the Coastal Adaptation and Resilience Plan that will include staff-coordinated public outreach incorporation. The plan is expected to be completed in early 2027.

Dredge Material Management effort is now being folded into the Coastal Adaptation and Resilience Plan. Consultant Kimley-Horn has been procured to delineate and map potential dredge material placement sites. The Planning Department has hired an intern to assist with this work. The Eastern Shore Dredge Material Management Initiative is now under active implementation through a recurring Project Management Team structure managing scope, schedule, budget, and partner coordination across A-NPDC, MPPDC, VMRC, ESRNWC, Carlexson Consulting, and technical support. Current work is focused on historic dredging and placement-site compilation, digital channel delineation development using best available data, channel screening and prioritization, permitting and constraints review, and early concept development for priority navigation and placement projects.

3571

A-N Ground Water Committee Projects

The Groundwater Committee will hold a working meeting to review research needs and solidify plans for the coming year. The session will further develop and prioritize project planning FY27. One priority candidate is the USGS Installation, Operation and Maintenance of a Subsidence Monitoring Network across the Eastern Shore. For this initiative, USGS has completed a project plan and cost estimate that is currently under review by the Groundwater Committee.

3401

VDOT Rural Transportation Plan

The FY 2027 Rural Work Program application and adopted resolution were submitted this Spring, with notice of award being made at the end of June. Staff have been asked to participate in training, including Arterial Management Plan development and commercial transportation planning. VDOT is currently auditing A-NPDC's Title VI Plan. Plan updates will be needed and will be based upon new federal executive orders as well as state regulatory changes.

Safety Action Plan - USDOT Safe Streets for All Program

Recommended countermeasures for the ten selected high injury sites have been finalized. The final draft of the Action Plan is complete. Kimley Horn will present the plan to the Accomack-Northampton Transportation District Commission at their regular meeting on July 7. The plan will also be presented to the Safety Action Plan steering committee on a date yet to be determined. Staff attended the monthly Accomack-Northampton Transportation District Commission to provide an update on project status.

3620

Delmarva Agricultural Community Resilience Project

This project, led by Virginia Tech and NOAA, is developing a regional collaborative of local and regional governments and extension organizations in rural areas of coastal Virginia, Maryland, and Delaware with the goal to build enduring capacity for planning and implementation of community supported risk reduction efforts that engage the strengths and capabilities of a broad range of actors in the rural coastal zone. The Eastern Shore of Virginia listening session took place and staff assisted with registration and facilitation at the meeting. The final report will be completed in approximately two years.

*VDACS-Aquaculture & Forestry Industries Development
(AFID) Fund Planning Grant*

Award of a \$34,910 grant to the A-NPDC for the aquaculture and forestry sectors of the Comprehensive Economic Development Strategy was received. Staff coordinated a second meeting of forestry stakeholders with the VDOF area forester to discuss forestry initiatives, including workforce development. This Forestry Advisory Committee feels very strongly that a sawmill is needed and a location in central Accomack would be ideal. Amish/Mennonite saw mill operators and other community members may have an interest in relocating here since the

quality and quantity of ESVA timber is high. The next meeting is in June. Outreach to form the Aquaculture Advisory Group has begun.

Continuum of Care (CoC)

The Community Partners of the Eastern Shore (CPES) General Membership meeting will be held on July 8th. Beginning July 1st, Lead Agency duties for the local Continuum of Care will move the Community Services Board. This is the norm for CoCs throughout the state. PDC staff will continue to work on associated CPES projects, including the Virginia Homeless Solutions program.

The Annual Point-In-Time Homelessness Count was conducted on the evening of January 28th. The preliminary number of people counted as sheltered was 31, however the final report included additional family members that were not included in the raw data. The final report count is 42 individuals, showing a marked increase over LY. Per the Chair's request, attached is a chart of homelessness data comparing our region to others in Virginia. The years represented

on the chart are 2024 and 2025. There is no published comparative data for 2026. Note, HUD does not publish this data by county.

3661

HUD Housing Counseling Services

The application for this funding cycle was submitted on April 30. Virginia Housing has indicated that awards will be announced in August and that level funding is expected. The period of performance will begin retroactively on October 1, 2025, and will run for an 18-month term. Staff is currently assisting 14 clients in pre-purchase counseling. Six have become mortgage-ready; however, five have chosen to delay purchasing and suspend counseling in hopes of lower interest rates and better housing options. One client ultimately determined that renting was the best option after three years of credit improvement and savings. Over the past three years, eight clients have achieved homeownership through the project, demonstrating the continued impact and effectiveness of our counseling services.

Virginia Housing Counseling & Education

Fair Housing, Rental Topics, and Financial Literacy classes are conducted during Section-8 briefings. The HCE grant application was submitted, and Virginia Housing has increased the total amount of funding available for this program. Award notifications are expected soon. On May 28, staff partnered with the Impact Center (formerly the Rosenwald School) in Cape Charles to host a free Heirs' Property Education seminar. The event drew 16 attendees and received very positive feedback. As a result, several participants have already applied for title searches, and some may qualify for financial support to assist with the drafting of wills.

bGlobal Consulting Website Improvement Subcontract \$ 5,400

This professional services contract is for updates and improvements to A-NPDC's full agency website. bGlobal will perform the work within a six-month timeframe and will perform web maintenance for one-year thereafter. Funding for this activity is provided by the Planning Department's Coastal Zone Management grant that is administered by the Virginia Department of Environmental Quality.

Commissioner Hart moved to authorize the A-NPDC to execute all of the above named contracts. It was seconded by Commissioner Crockett, the motion was carried by unanimous vote.

2026 General Assembly Employer Changes

House Bill 5/Senate Bill 199 - Paid Sick Leave Update

Pending different start dates, all Virginia employers are required to accrue minimum sick leave at a rate of one hour per thirty hours worked for each employee. For A-NPDC, the major change would be the addition of a sick leave fringe benefit for part-time workers.

Employers are allowed to elect to provide the expected sick leave at the beginning of the year and, if they provide 40 hours, meet the sick leave amount requirement. For the purposes of this law, it appears that A-NPDC will be an employer on January 1, 2029. This fringe benefit is not included in the FY27 draft budget.

Staff is monitoring this change and will review administrative requirements and propose a personnel policy to comply with this change.

SB 2/HB 1207 Paid Family Medical Leave Act (PFML)

Beginning April 1, 2028, employers and employees are required to make payroll contributions to the Virginia Employment Commission for the Virginia Paid Family Medical Leave Act which will allow up to twelve weeks of leave with wage replacement of up to 80% capped at 100% of the statewide average weekly wage. Claims will begin December 1, 2028.

Uses of the paid family and medical leave benefits include:

- The birth, adoption, or foster placement of a child;
- The employee's own serious health condition;
- To care for a covered family member with a serious health condition;
- To care for a covered service member who is the employee's next of kin or family member;
- For qualifying exigencies arising out of a family member's active duty; and
- To seek safety-related services for the employee or family member.

The contribution rates will be set by October 1, 2027. Currently in other states, the contribution is 0.88%-1.13% of gross wages. Virginia estimates 0.72%. The law requires employers to pay half of the contribution.

SB215 Pay Transparency

Civil penalties for employers for violation of the pay transparency law. An aggrieved prospective employee or employee may bring an action within one year.

B. No employer shall:

1. Seek the wage or salary history of a prospective employee;
2. Rely on the wage or salary history of a prospective employee in considering the prospective employee for employment;
3. Except as provided in subsection D, rely on the wage or salary history of a prospective employee in determining the wages or salary the prospective employee is to be paid upon hire;
4. Refuse to interview, hire, employ, or promote or otherwise retaliate against a prospective or current employee for not providing wage or salary history or requesting a wage or salary range;
5. Fail or refuse to disclose in each public and internal posting for each job, promotion, transfer, or other employment opportunity the wage, salary, or wage or salary range for the position; or
6. Fail to set a wage or salary range in good faith. Any analysis of whether the wage or salary range has been set in good faith shall consider, among other things, the breadth of such wage or salary range.

2% Bonus Payment

Accomack County has approved a 2% bonus payment for June 15.

Commissioner Hart moved to authorize to pay the 2% bonus. It was seconded by Commissioner Crockett, the motion was carried by unanimous vote.

13. Next Meeting

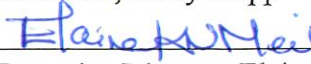
